These include, but are not limited to, equipment loss or breakage, theft, inclement weather, cold water, rough seas, strong tidal and other currents, navigational difficulties, collisions with other vessels and/or other obstructions, capsizing, illness and accidents in remote places and inaccessibility to prompt medical assistance. Such perils and risks and others, singularly or in combination, may result in my suffering, property damage, serious bodily injury (including mental or physical) or death.

I expressly agree on behalf of myself (and in the case of a guardian signing for a minor, on behalf of the minor) to accept and assume all responsibility and risk arising from my participation in the activity in which I am about to engage and travel to and from that activity and agree to hold Gary Bulla's Flyfishing Adventures harmless therefrom.

Gary Bulla's Flyfishing Adventures acts only as a representative for those providing services, meals, fishing, transportation and accommodations connected with these trips. Gary Bulla's Flyfishing Adventures is not to be held responsible for any act, omission or event of for any loss, injury or damage to or in respect to, is in no way to be considered as the principal operator of the subject services. I hereby release and forever discharge Gary Bulla's Flyfishing Adventures, its officers, directors, agents and employees from any and all liability claims, demands, actions, or rights of action which are related to, arise out of, or are in any way connected to my participation in this activity including specifically, but not limited to, the acts or omissions of Gary Bulla's Flyfishing Adventures, its agents, officers, directors or employees for any and all injury, death, illness, disease (whether mental or physical) and damage to myself or to my property.

### CANCELLATION POLICY

We run a small flyfishing company and only accommodate 7-11 clients per week. When you register we hold your spot. This means we turn away other clients. Long before your arrival we pay Baja Joe's Hotel in full, reserve fishing boats with our captains, purchase supplies and guarantee work to the support staff. A last-minute cancellation impacts many people, some of whom are dependent on their income to meet their basic needs. If an emergency arises and you find yourself having to cancel less than 90 days prior to departure try to find a replacement, we will do our best to help you.

Please read and acknowledge our cancellation policy before sending your deposit.

- 100% Refund with 90 days' notice prior to trip start date (less \$300.00 administration fee)
- 50% refund with 60-day notice prior to trip start date, but, your remaining funds can be applied to a future trip.
- No refund less than 60 days prior to trip start date unless your spot can be filled.

Postponed Trip: In the unlikely event of extreme adverse weather or other uncontrollable factors, we reserve the right to postpone the trip to a future date. Gary Bulla, doing business as Gary Bulla's Flyfishing Adventures is not responsible for expenses incurred by trip members in preparation for the trip (e.g., non-refundable airline tickets, personal gear bought for the trip, etc.), or during the trip. For this reason and in case of cancellation for personal reasons, sickness etc.,

**I highly recommend that clients arrange airline and vacation insurance that adequately covers such financial loss. It's cheaper than a fly line!**
